Please note: In order for your application to be considered complete, the Department of Homeland Security of the United States government requires the University to verify the financial resources of all international applicants. Forms I-20 or IAP-66 cannot be issued until this form is completed and we have received all supporting bank documents (unless your bank has certified this form).

PLEASE READ THE FOLLOWING INFORMATION CAREFULLY. THIS FORM IS AN ESSENTIAL PART OF YOUR STUDENT VISA PROCESS.

Bryant traditionally awards merit-based scholarships to a limited number of international applicants, and the scholarship letter can be included as a part of the overall funding amount. Students can also use loans, grants, scholarships from their home countries in order to demonstrate available funding.

The I-20 form, which indicates eligibility for a student visa, CANNOT BE ISSUED until an accepted student has submitted confirmation of attendance and the required deposit. This form will be used to enter the student's information into the US Immigration and Customs Enforcement (ICE) SEVIS system. Please print clearly in block letters or type your responses. The Certification of Finances and supporting bank statements, letters of certification of funds must:

- Demonstrate the availability of \$67,000 (based on the nine-month academic year);
- Be original documents (photocopies and faxes are not acceptable);
- Contain original signatures and a bank stamp or seal;
- Be dated no earlier than January 1, 2020 for Fall 2020 admission;
- Express all monetary amounts in U.S. dollars.
